

### Why Mondrian Fixed Income?

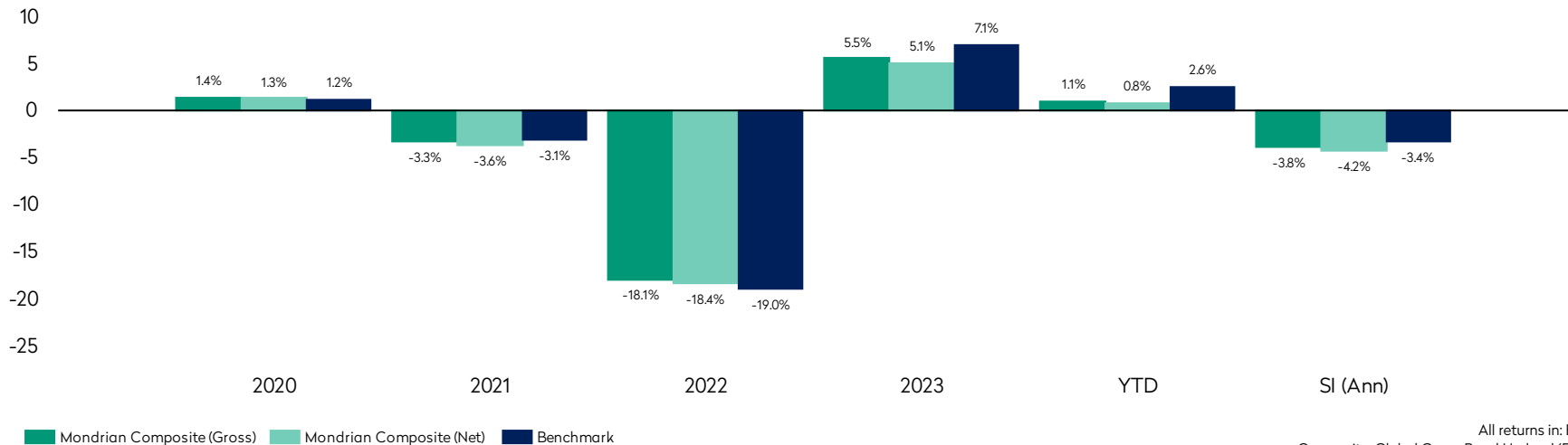
